

Club Assist Limited Warranty

Club Assist U.S. LLC (CA), an independent company from AAA, warrants only to the original purchaser that this battery is free of defects in materials and workmanship, for the designated number of months indicated on the front of the invoice. Should any battery fail to perform due to a defect in material or workmanship, and is not merely discharged, it should be returned to an authorized Service Provider or Distributor along with the original bill of sale.

Any removal of the battery by a third party will void warranty. Batteries will be warrantied as outlined below. No cash refunds.

Within thirty-six (36) months from the date of original purchase, all AAA branded batteries designated for passenger cars and sport utility vehicles will be replaced free of charge. Warranty does not cover removal of old battery or installation costs for the new battery.

Within three (3) months from the date of original purchase, all batteries designated as taxi or courier will be replaced free of charge. Warranty does not cover removal of old battery or installation costs for the new battery.

After the free-replacement period and for the remaining number of months of designated warranty period, the original purchaser may obtain a replacement battery of similar size upon payment of a prorated charge based upon the then-current published cost-per-month of the battery warranty multiplied by the number of full months lapsed since the date of the original purchase.

After the prorated warranty transaction is complete, a new warranty period begins and the replacement date becomes the new purchase date. All batteries replaced under the free-replacement period are covered by the continuation of the original warranty for the period set out on the original invoice. When a passenger car battery is used in a commercial application truck over one ton, marine service, recreational vehicle, etc. and is defective in material or workmanship and not merely discharged, it will be replaced free of charge within (6) months from the date of purchase.

CA is not responsible for batteries that fail due to improper charging or installation, broken container or cover, damage caused by fire, excessive heat, wreckage, explosion, freezing damage caused by abuse, neglect or the use of special additives introduced to the battery.

CLUB ASSIST IS NOT LIABLE FOR CONSEQUENTIAL, INCIDENTAL, COMMERCIAL OR PROPERTY LOSS OR DAMAGE, WHETHER BASED UPON TORT OR CONTRACT OBLIGATION.
